Below is a legal description of our Privacy Policy. Additionally, we want you to know that we will never sell or trade our mailing list or other personal information to any other source, nor will we ever request personal information that we do not absolutely need. If you register for a tour online, you will utilize our data server, **Jotform**, which collects and organizes your registration details: name, address, email, phone, travel preferences, birthdate. Our financial server, **Stripe**, is the payment service we use, which collects sensitive payment information such as credit card details. It is a highly secure service, that never sells or makes available your information beyond your specific transaction, nor does it save your information after the transaction has been completed. Stripe is certified as a Level 1 Service Provider, which is the highest level of certification for payment processors.

New York Theatre Tour, LLC, is committed to maintaining the privacy of personal information that you provide to us when using the New York Theatre Tour website. This Privacy Policy describes how we treat personal information received about you when you visit www.nytheatretour.com.

Privacy Policy Promise

While information is the cornerstone of our ability to provide superior service, our most important asset is our clients' trust. Keeping client information secure, and using it only as our clients would want us to, is a top priority for all of us New York Theatre Tour, LLC. Here then, then, is our promise to our individual customers:

Information We Collect

When you register for a tour, we may collect personally identifiable information from you that may include your name, address, telephone number, email address, birthdate.

Website Usage Information: We automatically collect IP addresses and website usage information from you when you visit our website. This information helps us evaluate how our visitors and customers use and navigate our website on an aggregate basis, including the number and frequency of visitors and customers to each web page, and the length of their visits.

How We Use Information Collected

We may use information in the following ways:

- For the purposes for which you specifically provided the information.
- To send you email notifications about our new or existing tours

or to otherwise contact you.

- We may also disclose or use your personal information when we, in good faith, believe that the law requires us to do so.

Cookies

We employ cookie technology to help visitors and customers move faster through our site. When you sign on to our Web site or take advantage of several key features, we may pass cookies to your computer. A cookie is a string of information that is sent by a Web site and stored on your hard drive or temporarily in your computer's memory.

Security

The personally identifiable information we collect about you is stored in limited access servers. We will maintain safeguards to protect the security of these servers and your personally identifiable information.

Internet-based Transfers

Given that the Internet is a global environment, using the Internet to collect and process personal data necessarily involves the transmission of data on an international basis. Therefore, by browsing www.nytheatretour.com and communicating electronically with us you acknowledge and agree to our processing of personal data in this way.
